Did you know?

If you have employees at risk from solvents, fumes, dusts, biological agents and other substances hazardous to health, then health surveillance may be required under the Control of Substances Hazardous to Health Regulations (COSHH 2002).

Healthscope (UK) Ltd provides a nationwide occupational health screening service with fully trained technicians in mobile clinics at your own premises. This means we can bring a top quality health surveillance service direct to your doorstep, thereby reducing the need for employees to leave the workplace to undertake mandatory health screening.

Fees for the following are available upon request:

- Fork Lift Truck Driver Medical
- Respiratory and Skin Checks
- Hearing Tests – any employees exposed to noise levels above 85dB should undergo an annual Hearing Test.
- Vision Screening
- Mask Fitting
- Hand Arm Vibration Level 2 (Questionnaire)
- Hand Arm Vibration Level 3 (Assessment)
Employees likely to exceed the daily exposure action level of 2.5m/s² A(8), should be under suitable health surveillance such as:
 - Completing a questionnaire annually for level 2.
 - Level 3/4 assessment is required if the health information in the given questionnaire warrants further screening
